The open space in front of emergency response stations and equipment, including [eyewash stations](#) and [emergency showers](#) is often viewed as empty space that can be used for storage. To remain OSHA compliant, your emergency stations must remain unobstructed and visible, and the NoTrax Eyewash Station Mat can help meet this requirement.

According to ANSI Z358.1 -2014, emergency response stations must be situated in a prominent, well-lit and clearly visible location, as well as being free from any obstructions. Emergency station mats can clearly identify the station, as well as discourage any placement of obstructions.

This emergency eyewash station mat is highly visible due to its bright green and yellow safety colors, which meet ANSI Z535.1 requirements. The elevated design with beveled ramp edging prevents trips and falls. Additionally, its drainage mat waffle grid features keep users above hazardous overflow and assure rapid drainage.
